WHEREAS, the Franklin County Commission is desirous of amending the provisions of *Franklin County Local Laws* 1973-446, 1971-491, 90-461 to remove certain expense allowances currently payable to the coroner by including the amount currently payable as an expense allowance in the coroner's annual salary, to be effective for the term of beginning after the 2026 General election; and

WHEREAS, the Franklin County Commission is further desirous of providing a method by which the coroner's salary would be increased by uniform increases in compensation granted equally to all county employees and specifying that the person holding the office of coroner may participate in any County or State sponsored health insurance or retirement plans under the same terms as all county employees.

NOW THEREFORE, BE IT RESOLVED by the Franklin County Commission that the Commission supports the introduction and passage of local legislation in the same or substantially similar form that shown on Exhibit "A" attached hereto.

BE IT FURTHER RESOLVED that the Chairman and is hereby authorized to present this Resolution and any attached exhibits to members of the Franklin County legislative delegation and to take such action as they deem necessary in connection with the introduction and passage of the proposed legislation attached as Exhibit "A" to this Resolution, including, but not limited to, publishing notice of the same once per week for 4 consecutive weeks in a newspaper or newspapers published in Franklin County.

4 Relating to Franklin County; to amend Sections 1973-446, 1971-5 491, 90-461 of the Code of Alabama 1975 (Local Laws)

- 5 491, 90-461 of the Code of Alabama 1975 (Local Laws); to authorize 6 the Franklin County Commission to appropriate and expend funds
- 7 for the operation of the office of Coroner of Franklin County,
- 8 Alabama; and to provide for the annual salary and other benefits
- 9 for the Corner of Franklin County, Alabama.
- 10 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:
- Section 1. Sections 1973-446, 1971-491, 90-461 of the Code of Alabama 1975 (Local Laws), is amended in its entirety to read as follows:
 - (a) Effective October 1, 2024, the Coroner of Franklin County shall receive an expense allowance in the amount of nine thousand, seven hundred dollars (\$9,700) per annum, which shall be in addition to all other expense allowances, compensation, or salary provided by law. The expense allowance shall be paid in equal monthly installments from the general fund of the county.
 - (b) Effective for the term of office beginning after the 2026 General Election, the expense allowance provided for in subsection (a) shall be null and void and the Coroner of Franklin County shall receive an annual salary of ten thousand dollars (\$10,000), to be paid in equal monthly installments from the general fund of the county. The salary in this subsection shall be the total compensation paid to the coroner, subject to the adjustments provided in subsection (c).
 - (c) In addition to the salary provided in subsection (b), the salary of the coroner shall be increased by any uniform increases in compensation granted equally to all county employees by the Franklin County Commission. In addition, the coroner may participate in the county health insurance plan and any retirement plan provided to county employees under the same terms as county employees.
 - (d) The Franklin County Commission may appropriate and expend county funds for the coroner's salary, benefits, and expenses necessary for the operation of the office of the coroner. The Franklin County Commission may provide the coroner with expenses for the operation of a motor vehicle or may furnish the coroner with the use of a county vehicle.
 - (e) The Franklin County Commission may authorize the coroner to appoint one or more deputy corners to perform the duties of the coroner in the absence of the coroner and provide for the compensation of any deputy coroner appointed.

Section 2. This act shall become effective immediately following its passage and approval by the Governor or upon its otherwise becoming law.

To: Franklin County Commission

I would like for you to consider the processes, regarding a raise for the County Coroner's Office. I know the processes will have to go to the State House for a vote for a local bill. I have spoken with Representative Jamie Kiel about this issue and he was in favor of the raise and he has already started some of the foundation that would be required. When I took this office I knew and fully understood that it was not an office with a sustainable paycheck; however within the past four years the expenses as well as the number of calls has increased substantially.

This past year alone we answered 200 calls. Each call requires at least a minimum of two hours per call. That is a total of 400 hours. That does not include the 21 autopsy calls that adds 3-4 hours to the call and that is does not calculate the time spent gathering medical records and other vital information to properly do a death certificate.

The Coroner and deputy Coroners are required by Alabama Coroner's Association, to have 12 hours a year of continuing education hours. These hours are done at the cost of the coroner and deputy coroners. Sometimes traveling is required for training due to a lack of training in our local areas.

Since I have taken office four years ago I have changed the office from what it used to be and I continue to work diligently to make it even better than what it is now. We have been able to start doing our own transports for autopsy which has saved us close to \$3,000.00 to \$6,000.00 a year for the past three years. I was also able to get a twelve person cooler at no cost to the county.

I would like to raise the Coroner salary from \$300.00 a year to \$5,800.00 a year. That will make the total to \$10,000.00. This includes leaving the expense budget at \$4,200.00. This will put us at the same pay as other counties with the same population as we have for our county. This may seem like a big increase from what it is now but when you add the total of hours that is put in for this job it still isn't enough.

I would like to thank you for helping me get this done for the coroner's office. For the most part this Commission has supported me in making changes to continue improving this office . I want this office to be something this county is proud of. I would like to thank you for the support and confidence you have instilled in me to do my job and to serve this county.




