Note: In accordance with Act No. 2008-75 enacted by the Legislature of Alabama, grants may be awarded only for the following purposes:

- 1. To promote economic development, education, recreation, conservation, and fire protection.
- 2. To enhance the education of the citizenry through activities, expenditures for capital improvements or equipment, to promote literacy, learning, arts appreciation, public health, and mental health.
- 3. To promote activities that provide human and social services which reduce the hardships of old age, poor health, or poverty.

Note: At the March 21, 2014 meeting of the FCCDC, it was approved to remind applicants of the following: "Any application presented to the FCCDC and any subsequent approvals thereof will assume to be presented for joint funding /consideration from Both the Senator's fund and the two representatives funds" and to be considered/approved/denied by the discretion of the members of the CCDC only. Further the fund was divided up during the 2014 election cycle to be 50% of the fund to the Senator, 80% to District 18 and 20% to District 7.
